Glenville State College will be honoring four different anniversary conference title teams on the evening of April 6, 2018 at the Brandi Bowen Invitational. This track meet which will take place on the D. Banks Wilburn Track at the I.L. & Sue Morris Stadium, Glenville, WV.

Festivities will take place at the GSC Brandi Bowen Invitational Meet on that Friday night.

1983 Men's Cross Country – 35-year Anniversary The famed "Blue Flex" captured their third consecutive title, and did so in dramatic fashion. The squad defeated a favored Fairmont State squad that had beaten them three times during the regular season, 40-42. Senior Larry Taylor '84 captured his third Runner of the Year honor, winning the individual title. Senior Steve Keenan '84 was also All-Conference with a fourth place finish, while freshman David Antonik was a top ten performer in seventh. Seniors Chris Keister and Steve Meckfessel both came in to seal the title with finishes of 13th and 15th.

We are proud that you are an alumna of Glenville State College and proud to recognize you in this week's Alumni Spotlight. 1988 Men's Cross Country – 30-year Anniversary The GSC "Crush Crew" rolled to their third consecutive league title, and the program's sixth in eight years. This "second wave" of the 80's Dynasty may have produced the most dominant win of all; placing all six runners in the top eight at the Championships. Junior Charles 'Bubby' Dent '89 won Runner of the Year honors, with senior Andy Jarrell '89 racing to the runner-up spot. The rest of the finishers in the thorough victory included sophomore Mickey Grass '92 in fourth, freshman Ed Lamp in fifth, junior Johnny Fitzpatrick in sixth, and freshman Tony Taylor in eighth. The Pioneers followed their league title with a sterling 19th place finish at the National Meet in Kenosha, Wisconsin. They became the first WVIAC team to place in the National Top 20.

1988 Women's Cross Country – 30-year Anniversary In Glenville's first season with a full women's team, the Lady Pioneers produced a league title with four freshmen of the six-runner team. Like the men, they put all six runners in the top eight. Freshman Katrina (Riggleman) Westfall '93 won Runner of the Year honors, while junior Lori (Barker) Gardner Woodson (the team captain) raced to a third place finish. Also in the leaders were freshman Mindi (Pickens) Schill '92 in fourth, freshman Tracy (White) Hunt '92 in fifth, sophomore Dawn (Farley) Petty '90 in sixth, and freshman Stacy (McKown) O'Dell in eighth. Barker would go on to be Runner of the Year in 1989. To this day, this is only title in the history of GSC women's cross country.

1993 Men's Track – 25-year Anniversary In both 1993 and 1995, Glenville's track squad's produced upset victories over a favored Wesleyan team. In 1993, the small but starstudded roster had several athletes produce big points. This unit included future GSC Hall of Famers in sprinter Chup Robinson '01, and All-American hurdler Kent Pilant '97. Other major scorers included sprinters Jesse Giles '04 and Richard Clark '93, jumper Aaron Mann '10, thrower Randall Olds '94, and hurdler Chris Cress '98, who would become an All-American later in his career. Several of these athletes were the most dominant athletes in their event areas during that era.
